The July Board Meeting was called to order on July 14, 2021, at 7:00 p.m. by Supervisor Larry Perron, following the Pledge of Allegiance. Pam Chipman and Andree Watson were in attendance, as well as the guests above.

A motion was made by Jim Callon and supported by Don Kucharczyk to approve the minutes of the Monthly Board Meeting on June 9, 2021. Motion carried.

A motion was made by Jim Callon and supported by Don Kucharczyk to approve the minutes of the Annual Board Meeting on June 9, 2021. Motion carried.

Discussion of special use permit for proposed EUPTA building with guests listed above. An application was made by the EUPTA for connection of sewer within the township for the new EUPTA building. **A roll call vote was taken. Don Kucharczyk, Cheryl Thoresen, Meg Stevens and Jim Callon voted yes. Larry Perron voted no. The application was accepted.**

A motion to approve the Vollick land division was made by Don Kucharczyk and supported by Jim Callon. Motion carried.**

Chuck Palmer discussed a judgment for McCormick and changes to the cemetery ordinance proposed at the Cemetery Board Meeting on July 6, 2021. Discussion of American Recovery Plan (ARP) money. Discussion of a letter to Mark Williams to clean up his property. Discussion of IRS outstanding payment from January.

Motion made by Don Kucharzyk and accepted by Jim Callon to accept July's bills.

June checks from #11042 to #11116 in the amount of \$116,803.83, including Electronic Transfers for payroll taxes, as well as monthly and annual fees to Quickbooks.
