

SOO TOWNSHIP MONTHLY BOARD MEETING

The September Board Meeting was called to order at 7:00 p.m. by the Supervisor, Larry Perron, followed by the Pledge of Allegiance. Jeff Killips and Chuck Palmer were in attendance.

A correction was made to the August minutes – the approval was for the corrected July minutes. **A Motion was made by Jim Callon and supported by Don Kucharczyk to approve the August monthly minutes as corrected. Motion carried.**

Jeff Killips gave the following monthly Fire Department report:

- Fire Department Open House is scheduled for September 30th from noon to 4:00. Announcement to be placed on website.
- Reid Metals, Inc. will take the water tank for \$25.00 scrap value.
- Propane Training will be scheduled for the Soo Township Firemen. The only requirement is that Soo Township pay for the instructor's lodging. This is a budgeted item.

The August budget vs actual was presented and discussed.

Andree Watson reported on the Chippewa County MTA meeting on August 17th.

Cheryl Thoresen and Andree Watson will be attending the MTA on the Road Workshop to be held at the Kewadin Casino on September 20th.

Soo Township has been invited to be a Township Focus in MTA's monthly magazine. Following discussion, we agreed to accept the invitation at a future date.

The township has received from US Department of the Interior, a Notice of Proclamation request from the Sault Ste. Marie Tribe of Chippewa Indians for less than 1 acre of land that exists between existing trust parcels to also be placed in Trust.

Treasurer Cheryl Thoresen reported that September 14th will be the last day for summer tax collection office hours.

Attorney Chuck Palmer reported that a Show Cause Hearing has been scheduled in October on the Bradley Case.

Letters have been written to 3 residents regarding violation of the Nuisance Ordinance.

A Motion was made by Jim Callon and supported by Don Kucharczyk to approve the payment of August bills from check #9047 to check #9060 totaling \$5,806.56 and September bills from check #9061 to check #9104 totaling \$31,310.16 including Electronic Payment in the amount of \$3,329.24 for August payroll taxes. Motion carried.
