Review of 2012/2013 fiscal year

- No monies spent on roads this fiscal year
- Soo Township developed a website
- Fire Department hosted the UP Firemen's meeting
- Land Divisions approved 7
- Permits approved 10
- Hall rented 33 times
- Board agreed to not raise the taxes again and to maintain the 1.6083 mills for operations
- Fire Department had an open house and barbecue
- Bill Nelson appointed to the Planning Commission
- Jeff Killips hired as custodian
- Soo Township established a Receiving Board for all elections
- Cathy Akre appointed Deputy Treasurer
- Support given to the Sault Tribe's efforts to supply city water to the Sault Tribe Housing located in Soo Township
- A Co-operative Mutual Aid Fire Control Agreement was signed with the DNR and local Fire Departments
- Four Mile Beach was designated Smoke free
- Board voted to purchase a new fire truck in FY2014

Mrs. Boone said that the residents were under the impression the roads would be blacktopped following the 4-year plan to improve the roads. The Supervisor answered by saying that he was part of the negotiations with the Road Commission at the time of improvements and that at no time was there any indication the roads were to be blacktopped. The question of blacktopping roads was never asked. Their request would be given consideration and that paving roads was dependant on funds available.
